**BIOGRAPHICAL INFORMATION**

I run my own law practice as a sole practitioner, in Prince George, BC. I have a general litigation practice, and have had since 2002. I have acted for private clients, government, and non-governmental entities, at all levels of the British Columbia Courts. I have represented well over 2500 clients. I am 53 years old.

I have volunteered my legal skills extensively, including for the Canadian Bar Association, the Native Friendship Centre, Prince George Immigrant and Multicultural Services Society, Activators Prince George (a federal "half-way house"), St. Patrick's House Society in Prince George, and many other more limited engagements. I was the recipient of the CBA's Equality and Diversity Award in 2013, and will continue that work if elected.

I am married to my spouse Lily, and have a large family that lives all over the Province.

**ELECTION STATEMENT**

The end of self-regulation is imminent. How it happens (or if), will be the most consequential development in the Law Society's history.

Lawyers' independence is essential to our democracy and to the public's confidence in the administration of justice. The Government's bare promise to maintain lawyers' independence is unconvincing, especially given their proposals suggest a regulatory structure that will significantly dilute our right to self-regulate. These proposals raise legitimate concerns that have not clearly been addressed by the Government.

The end of self-regulation will disproportionately affect the North, as there will be far fewer elected Benchers on the Board, and fewer still from our District. The current electoral district system ensures the public is represented from all areas of the Province. The North is a unique District and its lawyers are best suited to ensure its needs are met.

At this critical time it is important for the Benchers to be independent of government. If elected I will strongly advocate for the protection of lawyer independence and to ensure there are no structural changes to our governance that could threaten that bedrock principle or the essential role lawyers play in maintaining the rule of law.
