THIS COURT ORDERS that:

- 1. Charles Daniel Sam, also known as klatle-bhi, until such time as he becomes a member in good standing of The Law Society of British Columbia be permanently prohibited and enjoined from:
 - (a) appearing as counsel, advocate, representative or any other title which connotes an ability to appear on behalf of others,
 - (b) drawing, revising or settling a document for use in a proceeding, judicial or extrajudicial,
 - (c) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia,

- (d) giving legal advice,
- (e) making an offer to do anything referred to in paragraphs (a)-(d), and
- (f) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a)-(d)

for or in the expectation of a fee, gain, or reward, direct or indirect, from the person for whom the acts are performed.

- 2. Charles Daniel Sam, also known as klatle-bhi, until such time as he becomes a member in good standing of The Law Society of British Columbia, be permanently prohibited and enjoined from commencing, prosecuting or defending a proceedings in any court, other than representing himself as an individual party to a proceedings acting without counsel solely on his own behalf.
- 3. Charles Daniel Sam, also known as klatle-bhi, pay costs to The Law Society of British Columbia in the amount of \$1,500.
- 4. Lucius Tyler Lewis, also known as tah-sun-quay-ton, until such time as he becomes a member in good standing of the Law Society be permanently prohibited and enjoined from:
 - (a) appearing as counsel, advocate, representative or any other title which connotes an ability to appear on behalf of others,
 - (b) drawing, revising or settling a document for use in a proceeding, judicial or extrajudicial,
 - (c) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia,
 - (d) giving legal advice,
 - (e) making an offer to do anything referred to in paragraphs (a)-(d), and
 - (f) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a)-(d)

for or in the expectation of a fee, gain, or reward, direct or indirect, from the person for whom the acts are performed.

5. Lucius Tyler Lewis, also known as tah-sun-quay-ton, until such time as he becomes a member in good standing of the Law Society, be permanently prohibited and enjoined from commencing, prosecuting or defending a proceedings in any court, other than representing himself as an individual party to a proceedings acting without counsel solely on his own behalf.
