



RULE OF LAW ESSAY CONTEST FOR BC SECONDARY SCHOOL STUDENTS

2016-2017 Essay Topic

The topic for the Law Society of British Columbia's 2016-2017 Rule of Law essay contest is:

How would you explain the Rule of Law to a fellow student who has never heard the term before? You might discuss why the Rule of Law is important, and how it impacts our daily lives. You might also discuss any current events involving threats to the Rule of Law.

Eligibility Criteria and Submission Guidelines

The essay contest is open to all Grade 12 students who are enrolled in the 2016/2017 academic year and any secondary school students currently enrolled in, or who have taken, Law 12 or Civic Studies 11 in British Columbia.

Deadline for submissions is Monday, April 10, 2017. Late entries will not be accepted.

- Students will be expected to submit an original essay that addresses the topic and demonstrates their understanding of the Rule of Law, its principles, and its significance in civil society.
- The submission must be the original work of the student. Research, writing and editing must be done solely by the student.
- The essay must be a minimum of 1000 words to a maximum of 1500 words.
- Students must cite at least 3 varied sources such as reference materials, government documents, legislation, and published articles in the body of the essay using any academically acceptable referencing style, and must include a bibliography.
- Citations or bibliography should not be included in the word count.
- One entry per student. Further submissions with revisions will not be accepted.

- Essays must be typed and double spaced, and include a cover sheet with the student's full name, name of school and grade, confirmation of enrollment, email address, and phone number. Confirmation of enrollment can be noted by including the student's student number, school name and teacher when the essay is submitted.¹
- Entries should be submitted as a PDF or MS Word document by email to The Law Society at essay@lsbc.org or by mail to The Law Society of British Columbia, 845 Cambie Street, Vancouver BC V6B 4Z9, to the attention of the Policy and Legal Services Department.

Judging Criteria

Entries will be judged on a clear expression of ideas, an understanding of the topic, originality, and excellence in writing.

- Content 70%, presentation 30%.
- The winner and runner up will be chosen by a judging panel representing the Law Society and the education community.
- Any submissions that do not comply with the eligibility criteria and submission guidelines will not be considered.

Award Presentation and Publication

- The first prize winner will receive an award of \$1000; the runner up will receive \$500.
- The first place winner and runner up will be invited to a special awards presentation held at the Law Society in Vancouver, BC. Travel and accommodation costs for a student not living in Metro Vancouver will be provided by the Law Society.
- Both the winning and runner up essays will be profiled on the Law Society's website. The Law Society will issue a news release announcing the names of the winner and runner up.
