In order to be considered for any session, PLTC applications must indicate a first choice and a second choice that is either later or in a different location. Plan to attend either session until official confirmation of acceptance into a PLTC session is received. There is no guarantee that you will be admitted to your first choice, especially for the highly requested May Vancouver PLTC session. If you request the May Vancouver session as your first choice, select your second choice wisely. You will receive the official confirmation of acceptance four to six weeks after the application deadline.
