Compulsory Professional Liability Insurance for Part-time Practice

You may apply for an insurance fee discount if you are engaged in the private practice of law, related professional services and activities that further those services for an average of 25 hours per week or less.

The term “activities that further those services” includes but is not limited to practice management, administration and promotion, and professional duties or representation on bodies such as the Law Society of British Columbia, the Canadian Bar Association, the Continuing Legal Education Society and other organizations. The term “an average of 25 hours per week or less” means 25 hours per week or less **on average** over successive six-month periods (January to June; July to December), starting from the effective date of your part-time practice and ending when you notify the Law Society of a change in your practice status.
