## **Our Mandate**

THE LAW SOCIETY WAS CREATED BY THE LEGAL PROFESSION ACT, WHICH GIVES IT THE AUTHORITY TO DETERMINE THE QUALIFICATIONS REQUIRED TO PRACTISE LAW IN BC, TO ESTABLISH RULES AND A CODE OF CONDUCT FOR LAWYERS, AND TO ENFORCE THOSE RULES. BUT MOST IMPORTANTLY, THE OPENING LINES OF THE ACT SPECIFY THAT ALL OF THESE RESPONSIBILITIES FALL UNDER A BROADER MANDATE "TO UPHOLD AND PROTECT THE PUBLIC INTEREST IN THE ADMINISTRATION OF JUSTICE." BEYOND ITS CORE MANDATE OF SETTING STANDARDS AND ENFORCING RULES, THE LAW SOCIETY SPEAKS OUT ON BEHALF OF THE PUBLIC ON ISSUES AFFECTING THE JUSTICE SYSTEM IN BC AND THE DELIVERY OF LEGAL SERVICES IN THIS PROVINCE.

# **President's Message**

2018 was a busy and productive year as the Law Society reached important milestones toward meeting the goals of its 2018-2020 Strategic Plan.

Early in the year the Benchers established a task force to address mental health in the legal profession, one of the priorities in our current strategic plan. The task force examined ways to reduce the stigma of mental health issues and the potential role our admissions and discipline processes may have in supporting a healthy profession that better serves the public. In December, all of the recommendations in the task force's first interim report were approved, including designing educational training programs for Law Society employees and establishing a communications strategy to enhance awareness of the issue.

The Law Society engaged with the provincial government on a range of issues. I met with Attorney General David Eby, QC, a number of times throughout the year. Each time we met, I stressed the importance of adequate public funding for criminal and family legal aid in BC. I was heartened by the support of Law Society members, who at the December AGM passed a resolution calling for the Benchers to continue advocating for legal aid funding as well as to encourage lawyers to perform pro bono work.

Over the course of the year, the Law Society moved ahead with regulatory innovation, completing a law firm regulation pilot project. The pilot tested the functionality of its online registration and self-assessment platforms. The completed assessments of policies and processes at select BC firms will help the Law Society as it takes the next steps toward implementing law firm regulation.

In July, the Benchers adopted a Truth and Reconciliation Action Plan which will guide the Law Society in its ongoing response to the Truth and Reconciliation Commission's calls to action. Concrete steps that we took in 2018 include approving Indigenous intercultural competence training as a component of continuing professional development, and adding Indigenous intercultural competence, Indigenous child welfare, and Indigenous sentencing sessions to the Professional Legal Training Course. A key part of the action plan addresses increasing Indigenous representation in all aspects of the Law Society, including on the committees that advise the Benchers on key regulatory responsibilities, such as lawyer education, staff recruitment, legal aid, and the Law Society's ongoing work at responding to the commission's calls to action.

# President's Message ... continued

The Law Society hosted two important public events in the year. In June, the second annual Rule of Law lecture addressed the intersection of social media and the rule of law. The lecture featured former Supreme Court of Canada Justice Binnie, QC, as well as Peter A. Allard School of Law Dean Dr. Catherine Dauvergne, and journalist Jonathan Kay. In November, the Second Legal Aid Colloquium was moderated by the Honourable Bruce Cohen, QC, and brought together a range of views and perspectives from communities and service agencies outside the legal profession that will help inform the Law Society's efforts to improve legal aid funding through engagement with the profession, the public and the provincial government.

Throughout the year, the Law Society worked closely the Federation of Law Societies of Canada as it drafts national standards on regulations aimed at combating money laundering. In addition to consulting with the profession on new draft rules, the Law Society took steps to ensure the profession is well aware of all the anti-money laundering rules that apply to trust funds, and increased audits of lawyer trust accounts to ensure compliance. The Alternate Legal Service Provider Working Group that I chaired launched a consultation on a draft proposal on what services might be provided by members of a new category of licensed professional in the area of family law. This sparked an important conversation in the profession, providing valuable input to the Benchers as they continue to work toward drafting a framework for licensing and regulating new categories of licensed paralegals.

It was a busy and productive year, and I know that 2019 President Nancy Merrill, QC, will ensure continued progress toward meeting the goals of our strategic plan. She will be supported by Craig Ferris, QC, as first vice-president and Dean Lawton, QC, as second vice-president, along with CEO Don Avison and the dedicated staff of the Law Society. I would like to thank Don and all of the outstanding Law Society staff, for their help and support, and my fellow Benchers for their commitment and hard work.

# **CEO's Message**

2018 was a year of change for the Law Society. The year began with me assuming my role and a new <u>strategic</u> <u>plan</u> that keeps us focused on protecting consumers of legal services while also improving the availability of legal services to the public. Over the course of the year, we welcomed new staff and new members to our governing board of Benchers, and we revitalized engagement with a new provincial government. It was a year that invited everyone to look at things with fresh perspective.

Throughout these changes, the Law Society continued to fulfil its core regulatory responsibilities. Our professional training course accommodated increasing numbers of law students seeking to become licensed lawyers. Practice advisors provided guidance to lawyers seeking information on new and challenging professional issues. We completed another audit cycle of all law firms and initiated a more stringent audit program for law firms working in areas more vulnerable to organized criminals looking to launder illicit funds. We continued to investigate every complaint we received and to reduce the time to resolution.

In the pages that follow, we provide data and information that demonstrates the progress made on our strategic goals this year. We have introduced new, objective measures of accountability. For example, the charts on page 11 illustrate the effectiveness of our audit program, with 463 audits in 2018 resulting in 74 referrals to professional conduct investigation. We are also introducing new accountability measures, illustrated on pages 9 and 10, which demonstrate the effectiveness of our investigation and resolution of complaints.

Beyond our core regulatory processes, we also are reporting on the substantial progress made this past year toward goals set out in the strategic plan. On pages 6 and 7 you will find a summary of the initiatives, including our Truth and Reconciliation Action Plan, our vision for legal aid, and our mental health initiative.

All of these initiatives and the progress that we made on them are only possible because of the hard-working people at the Law Society. They continue to be focused on our top priority of serving the interests of British Columbians, while understanding the realities of the legal profession. They, and I, remain dedicated to supporting lawyers in providing competent, honourable, professional services.

# **Strategic Plan Progress 2018**

The Law Society is governed by the *Legal Profession Act*, which requires that it:

- protect the rights and freedoms of all persons;
- ensure the independence, integrity, honour and competence of lawyers;
- establish standards and programs for the education, professional responsibility and competence of lawyers;
- regulate the practice of law; and
- support lawyers in fulfilling their duties in the practice of law.

The 2018-2020 Strategic Plan identifies areas within this mandate that require particular attention, sets out goals and outlines initiatives aimed at achieving those goals. In 2018 the Law Society reached the following milestones toward fulfilling those goals.

# Goal: Ensure the public has better access to justice

The Law Society continued to pursue the <u>Vision</u> for <u>Publicly Funded Legal Aid in BC</u> that was approved by the Benchers in 2017. President Miriam Kresivo met with Attorney General David Eby on several occasions, and at each occasion stressed the importance of adequate public funding for legal services

The Law Society sought input on a draft proposal regarding a new category of licensed professional in the area of family law. This sparked an important conversation within the profession, which will guide the Benchers as they continue to consider both the challenges and the opportunities that licensed paralegals present in addressing the need for better access to justice.

### Access to Justice

The Law Society provided \$2.5 million in funding for Courthouse Libraries of BC. Through its expanding digital collections, online training, and 30 physical locations, CLBC provides lawyers and the public with access to legal information and help finding and using that information. The Law Society also provided \$365,000 in funding for pro bono and access to legal services programs administered by the Law Foundation of BC.

### Goal: Identify and implement appropriate responses to the Truth and Reconciliation Commission of Canada's calls to action

The Benchers approved a <u>Truth and Reconciliation</u> <u>Action Plan</u>. Developed in consultation with Indigenous community leaders, it will guide the Benchers as they continue to respond to the findings of the commission.

Indigenous intercultural competence training was approved as a component of the continuing professional development program for lawyers. Sessions relating to intercultural competence and multiple aspects of the law as it relates to Indigenous people were incorporated into the Professional Legal Training Course required of new lawyers entering the profession.

### **Truth and Reconciliation**

At the 2018 retreat in Osoyoos, the Benchers learned about local Indigenous laws and traditions from Dr. Jeanette Armstrong, a Syilx First Nation leader and Canada Research Chair in Indigenous Knowledge and Philosophy at UBC-Okanagan. Truth and Reconciliation Commissioner Dr. Marie Wilson shared her perspective on challenges and opportunities that lie ahead.

# Goal: Mitigate risk, prevent misconduct and improve regulatory outcomes

The Law Society successfully rolled out a trial of its proposed regulatory framework for law firms. A sample group of law firms registered online and completed a selfassessment aimed at helping firms assess their management policies and processes.

The Benchers approved the recommendations of the <u>first interim report of the</u> <u>Mental Health Task Force</u>. These include, among other things, providing discipline and credentials staff with training to improve awareness of mental health and substance use issues, and working with the Credentials Committee to re-evaluate the Law Society's approach to inquiries into mental health and substance use in its admission program.

### Goal: Ensure that appropriate standards are maintained for ethical and professionally responsible practice of law

The Law Society contributed significantly to the Federation of Law Societies of Canada's revision of its model rules aimed at combatting money laundering. The federation adopted updated model rules in October and these will guide the Acts and Rules Committee as it drafts revisions to Law Society Rules, expected to be presented to the Benchers for consideration in the coming year.

### Goal: Assist lawyers in fulfilling their duties

The Mental Health Task Force interim report approved by Benchers in December includes recommendations aimed at helping lawyers with mental health and addiction issues, including encouraging practice advisors to discuss availability of confidential consultations and referral resources.

### Goal: Ensure the public has greater confidence in the rule of law and the administration of justice by Identifying opportunities for public discussion

The Law Society hosted two public events: the second annual Rule of Law lecture addressed the role of technology and social media; and the second Legal Aid Colloquium produced a range of perspectives that will help the Law Society as it continues to promote its Vision for Publicly Funded Legal Aid in BC. It also sponsored its third annual essay contest for high school students on the topic of social media and the rule of law.


#### **Proactive Regulation**

The Law Society successfully completed a law firm regulation pilot project. Select firms were asked to register and complete self-assessments of their policies and processes. The Law Society will take results of the pilot into consideration as it considers next steps in this proactive approach to regulation.




### PROFESSIONAL CONDUCT AND DISCIPLINE

National Standards: In 2018 the Federation of Law Societies of Canada approved National Discipline Standards, including the following:

- 80% of all complaints are resolved or referred for a disciplinary or remedial response within 12 months
- 90% of all complaints are resolved or referred for a disciplinary or remedial response within 18 months

Law Society of BC: 88% of complaint files closed in 2018 were closed within one year; 92% were closed within 18 months



\*prior regulatory involvement includes: interim proceedings, administrative suspensions, Custodianship involvement, Credentials involvement, referrals to Practice Standards, and referrals to the Discipline Committee. Also included are interim undertakings given during the course of an investigation





### TRUST ASSURANCE

All law firms are subject to accounting and reporting standards set out in the Law Society Rules. Every firm must file an annual trust report and is subject to compliance audits.

Every law firm that handles trust funds is audited at least once every six years. In 2019 the Law Society will increase the audit cycle to every four years for areas of practice considered to be at elevated risk.




\*As the result of an audit, further action may be required, including a request for further documentation, a visit to the firm, or a requirement to complete an accountant's report.





### PROFESSIONAL LEGAL TRAINING COURSE

All new lawyers in BC must pass the Professional Legal Training Course, a full-time, ten-week program aimed at helping new lawyers bridge the gap between law school and practice.




# Legal Profession in BC
