CONSENT ORDER

THIS COURT ORDERS that the Respondents, Steven Serenas and S. Serenas & Associates (1988) Inc., until such time as they become members in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from:

- (a) drawing, revising or settling a petition, memorandum or articles under the Company Act, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration,


organization, reorganization, dissolution or winding up of a corporate body;

- (b) drawing, revising or settling a will, deed of settlement, trust deed, power of attorney or a document relating to any probate or letters of administration or the estate of a deceased person;
- (c) drawing, revising or settling a document relating in any way to proceedings under a statute of Canada or British Columbia;
- (d) giving legal advice; and
- (e) offering to or holding themselves out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (d) above;


for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed;

THIS COURT FURTHER ORDERS that the Petitioner be awarded its costs in the amount of \$400.00.



