**THE PETITION** of the Petitioner, The Law Society of British Columbia, coming on for hearing at Vancouver, British Columbia, on the 17<sup>th</sup> day of March, 2005, and on reading the Petition and Affidavits filed herein, and on hearing Carmel Wiseman, Counsel for the Petitioner, and Raghbir Kaur Gill also known as Ronnie Gill, appearing on her own behalf, and **BY CONSENT**;

**THIS COURT ORDERS** that, except as permitted by federal legislation or provincial legislation that authorizes non-lawyers to provide legal services, the Respondent, Raghbir Kaur Gill also known as Ronnie Gill, until such time as she becomes a member in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from:

- (a) appearing as counsel or advocate;
- (b) drawing, revising or settling a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an


application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body;


- (c) drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
- (d) drawing, revising or settling a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or letters of administration or the estate of a deceased person;
- (e) drawing, revising or settling a document relating in any way to proceedings under a statute of Canada or British Columbia;
- (f) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (g) agreeing to place at the disposal of another person the services of a lawyer;
- (h) giving legal advice; and
- (i) offering to or holding herself out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (h) above;

for or in the expectation of a fee, gain or reward direct or indirect, from the person from whom the acts are performed; and

**THIS COURT FURTHER ORDERS** that the Respondent Raghbir Kaur Gill also known as Ronnie Gill pay the Petitioner its costs at Scale 3, such costs not to include costs for the hearing of the application March 17, 2005.
