- (d) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;


- (e) giving legal advice; and
- (f) offering to or holding themselves out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (e) above;


for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed, **SAVE AND EXCEPT:**

- (a) where employed and supervised by a practising lawyer;
- (b) where permitted by statute; or
- (c) when appearing as a party in an action; and
