- (d) drawing, revising or settling a will, deed of settlement, trust deed, power of attorney or a document relating to a probate of letters of administration or the estate of a deceased person;
- drawing, revising or settling a document relating in any way to proceedings under a statute of Canada or British Columbia;
- (f) drawing, revising or settling an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (g) doing any act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (h) agreeing to place at the disposal of another person the services of a lawyer;
- (i) giving legal advice;
- offering to or holding himself out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (i) above;

for or in the expectation of a fee, gain or reward, direct or indirect, from the person for whom the acts are performed;

THIS COURT FURTHER ORDERS THAT the Respondent, Ronald William Kostyk, until such time as he becomes a member in good standing of the Law Society of British.

Columbia, be permanently prohibited and enjoined from representing that he is a lawyer or barrister or solicitor or legal counsel or otherwise a member of the Petitioner;

AND THIS COURT FURTHER ORDERS that the Petitioner be awarded costs and disbursements against the Respondent in the amount of \$300.00.
