AND UPON NOTING THAT the Defendant, Ronald William Kostyk, has agreed to make partial restitution to the Affiants, Elmer Heppner, Glen Franklin Johnson and Ronald Jeffrey Tekano, in the amount of \$12,000 in lieu of a fine in the amount of \$12,000 or an order of committal, which restitution will be paid in the amount of \$150.00 per month to the Plaintiff, the Law Society of British Columbia, to be distributed to the Affiants in the following amounts:

Glen Franklin Johnson	\$1,575.00
Ronald Jeffrey Tekano	\$5,500.00

THIS COURT ORDERS that the Defendant, Ronald William Kostyk, be held in contempt of this Court for disobeying the Order pronounced July 20, 1995 and entered on July 26, 1995 in this action;

THIS COURT FURTHER ORDERS that the Defendant, Ronald William Kostyk, pay to the Plaintiff the sum of \$12,000.00 in lieu of a fine or an order of committal by monthly instalments of \$150 per month payable on the 1st day of March 2009 and on the 1st day of each month thereafter until the sum of \$12,000.00 is paid in full;


THIS COURT FURTHER ORDERS that the Defendant, Ronald William Kostyk, continue to be enjoined from directly or indirectly representing, or acting in a manner likely to cause confusion, that he is a member of the Plaintiff, or holds the qualifications necessary to be a member, or is otherwise qualified or entitled to provide legal services, whether or not such services are provided in expectation of a fee or reward;



THIS COURT FURTHER ORDERS that the Defendant, Ronald William Kostyk, continue to be required to disclose, by providing a copy of this Order, to members of the public who wish to use his services, lawyers with whom he may deal, and any judge, administrative body or tribunal before which he may appear that:


- (a) he is not a lawyer;
- (b) he has never attended an accredited law school;
- (c) he has no legal education or training;
- (d) he is not permitted to receive a fee; and
- (e) he is required by Court Order to make such disclosure;

AND THIS COURT FURTHER ORDERS that the Plaintiff be awarded costs and disbursements against the Defendant in the amount of \$300.00.
