- (f) agreeing to place at the disposal of another person the services of a lawyer;
- (g) giving legal advice;
- (h) offering to or holding himself out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (g) above;

foror in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed; and

- 2. The Respondent, until such time as he becomes a member in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from holding himself out as a lawyer or identifying himself in any way that suggests he is a lawyer.
- 3. Costs and disbursements be awarded to the Petitioner in the amount of \$500.00.
