#### THIS COURT ORDERS THAT:

- 1. The Respondent, Vincent Macalipay also known as Vicente Macalipay, until such time as he becomes a member in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from:
  - (a) appearing as counsel or advocate;
  - (b) drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
  - (b) drawing, revising or settling a document relating in any way to proceedings under a statute of Canada or British Columbia;

- (c) agreeing to place at the disposal of another person the services of a lawyer;
- (d) giving legal advice; and
- (e) offering to or holding himself out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (d) above;

for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed PROVIDED THAT nothing herein prevents the Respondent from providing services he is entitled to provide pursuant to the *Immigration* and Refugee Protection Act, S.C. 2001, c. 27 while a registered member of the Canadian Society of Immigration Consultants;

- 2. The Respondent, until such time as he becomes a member in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from holding himself out as a lawyer or identifying himself in any way that suggests he is a lawyer or any business he operates is a law firm; and
- 3. The Petitioner be awarded its costs.
