ON THE APPLICATION of the Petitioner, the Law Society of British Columbia, without a hearing, and on reading the Petition and the Affidavits of Cynthia Letal sworn September 16, 2009, Shawn Mahon sworn September 18, 2009, Jacqueline Drozdowski sworn September 23, 2009, and the Affidavit of Service of Bernard Ball sworn November 18, 2009 filed herein;

**THIS COURT ORDERS** that

1. The Respondent, Dwayne Eric Hunte, until such time as he becomes a member in good standing of the Law Society of British Columbia, be permanently prohibited and enjoined from:

- (a) appearing as counsel or advocate;
- (b) drawing, revising or settling a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the

incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body;


- (c) drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
- (d) drawing, revising or settling a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or letters of administration or the estate of a deceased person;
- (e) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia;
- (f) drawing, revising or settling an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (g) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (h) agreeing to place at the disposal of another person the services of a lawyer;
- (i) giving legal advice;
- (j) offering to or holding himself out in any way as being qualified or entitled to provide to a person the legal services set out in (a) through (i) above;

for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed;



2. The Respondent, Dwayne Eric Hunte, until such time as he becomes a member in good standing of the Petitioner, be permanently prohibited and enjoined from representing that he is a lawyer in British Columbia or falsely representing that he or any other person is a lawyer of another jurisdiction permitted to practise law in British Columbia or in another jurisdiction in Canada; and

3. The Petitioner be awarded its costs.
