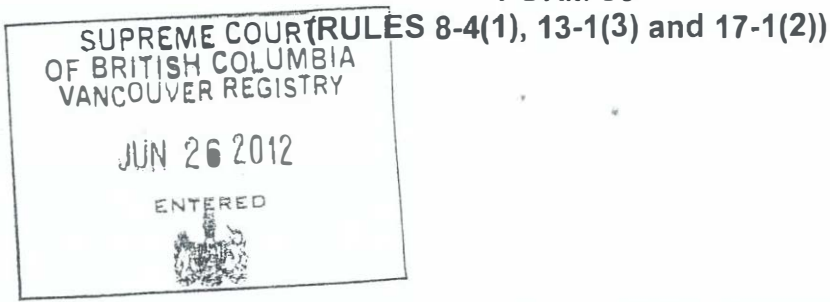

ON THE APPLICATION of the Petitioner, the Law Society of British Columbia, coming on for hearing at Vancouver on 30 April 2012 and 22 May 2012 and on hearing Michael J. Kleisinger and Graeme Keirstead, lawyers for the Petitioner and the Respondent, Marlane Lauren, on her own behalf;

THIS COURT ORDERS THAT:


1. Marlane Lauren pay the amount of \$3,000 to the Petitioner, the Law Society in trust for Brad Flewelling and pay the amount of \$1,000 to the Law Society in trust for Robin Loder in equal monthly installments of \$1,000 each to commence September 1, 2012 and to end December 1, 2012;

2. Marlane Lauren pay the costs to the Law Society ordered by Mr. Justice Davies on August 17, 2011 as follows: the amount of \$2,860.50 to be paid to the Law Society on or before December 31, 2012 and the amount of \$2,860.50 to be paid to the Law Society on or before February 28, 2013;
3. Marlane Lauren pay a fine in the amount of \$5,000 to this court on or before May 31, 2013;
4. Marlane Lauren pay the Law Society special costs in the amount of \$2,500 for this application on or before May 31, 2013;
5. Mr. Justice Abrioux be seized of any further applications having to do with this Order and the injunction order of Mr. Justice Davies pronounced August 17, 2011; and
6. Marlane Lauren's signature be dispensed with to approve the form of this order.
