#### ORDER

THE APPLICATION of the Petitioner, the Law Society of British Columbia (the "Law Society") coming on for hearing at Vancouver, British Columbia on the 26th day of June, 2013, and on hearing Paula H. Kalsi, counsel for the Petitioner, and Roald Thomas appearing on his own behalf and on behalf of Ignition Strategies Inc., the Respondents.

THIS COURT ORDERS that:

1. Roald Thomas, until such time as he becomes a member in good standing of the Law Society, and Ignition Strategies Inc. be permanently prohibited and enjoined from:

(a) appearing as counsel or advocate, representative, or any other title which connotes an ability to appear on behalf of others,

(b) drawing, revising or settling

(i) a petition, memorandum, notice of articles or articles under the Business Corporations Act, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body,

(ii) a document for use in a proceeding, judicial or extrajudicial,

(iii) a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or letters of administration or the estate of a deceased person,

(iv) a document relating in any way to a proceeding under a statute of Canada or British Columbia, or

(v) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office,

(c) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages,

(d) agreeing to place at the disposal of another person the services of a lawyer,

(e) giving legal advice,

(f) making an offer to do anything referred to in paragraphs (a) to (e), and

(g) making a representation that he or she is qualified or entitled to do anything referred to in paragraphs (a) to (e)

for or in the expectation of a fee, gain or reward, direct or indirect from the person for whom the acts were performed.

2. Roald Thomas be required to inform the Unauthorized Practice Counsel of the Law Society of any proceeding or legal matter in which he is involved in any manner whatsoever, other than representing himself as an individual party to a proceeding acting without counsel solely on his own behalf.
