ON THE APPLICATION of the Petitioner, the Law Society of British Columbia, without a hearing and by consent:

## THIS COURT ORDERS THAT:

- 1. The Respondents, Nitya Nand a.k.a. Nick Nand, Joysika Nand, and Nirmala Nand a.k.a. Nancy Smith, until such time as they become members in good standing of the Law Society and the Respondent, Vancouver Credit Collection Inc., be permanently prohibited and enjoined from:
  - (a) drawing, revising or settling

- (i) a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up or a corporate body.
- (ii) a document for use in a proceeding, judicial or extrajudicial,
- (iii) a document relating in any way to a proceeding under a statute of Canada or British Columbia,
- (iv) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office, and
- (b) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages,
- (c) agreeing to place at the disposal of another person the services of a lawyer;
- (d) giving legal advice;
- (e) making an offer to do anything referred to in paragraphs (a) through (d);
- (f) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a) through (d)

for or in the expectation of a fee, gain or reward, direct or indirect, from the person for whom the acts are performed;

2. The Law Society be awarded its costs of \$750.
