ON THE APPLICATION of the respondent, Bradley Jonathan Renford doing business as Concise Paralegal Services ("Mr. Renford") dated September 23, 2015 and the application of the petitioner, the Law Society of British Columbia (the "Law Society"), dated 6 November 2015, coming on for hearing at Vancouver, British Columbia, on 27 November 2015, and on hearing Michael J. Kleisinger, lawyer for the petitioner, and Mr. Renford, appearing on his own behalf, and BY CONSENT, except with respect to costs:

THIS COURT ORDERS THAT:

1. Mr. Renford's application is dismissed.
2. The order of Madam Justice Koenigsberg pronounced 6 October 2014 is varied replaced by this Order.

3. Until such time as he becomes a member in good standing of the Law Society, Mr. Renford is permanently prohibited and enjoined from:

- (a) drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
- (b) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia;
- (c) giving legal advice;
- (d) making an offer to do anything referred to in paragraphs (a) to (c); and
- (e) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a) to (c)

for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed.

4. Further to paragraph 3 of this Order, Mr. Renford must not provide legal services to any person or business for or in the expectation of a fee, gain or reward, direct or indirect from that person or business, including legal research and drafting or preparing legal forms or documents.
5. Until such time as he becomes a member in good standing of the Law Society and regardless of whether he charges a fee for doing so, Mr. Renford is permanently prohibited and enjoined from commencing, prosecuting or defending a proceeding in any court other than representing himself as an individual party to a proceeding, acting without counsel, solely on his own behalf.
6. The Law Society is awarded its costs fixed at \$1,000, inclusive of disbursements, for the applications heard on 27 November 2015.
7. The Law Society remains entitled to its costs of \$3,130 as awarded by the Order of Madam Justice Koenigsberg on 6 October 2014.


8. Mr. Renford's approval of the form of this Order is not required.
