ON THE HEARING OF THE PETITION OF the Petitioner, The Law Society of British Columbia, coming on for hearing at Vancouver, B.C. on 03 March 2017 and on hearing Elizabeth B. Lyall, Q.C. and Michael J. Kleisinger, counsel for the Petitioner and Surinder Singh Trehan, appearing on his own behalf and on behalf of all of the Respondents;

THIS COURT ORDERS that:

- 1. Until such time as the Respondent, Surinder Singh Trehan ("Mr. Trehan"), becomes a member in good standing of the Law Society of British Columbia, Mr. Trehan, personally or through any other entity, A S Canada & USA Immigration Services Ltd. ("A S Canada & USA") and Canada and USA Immigration Services Ltd. ("Canada and USA") (together, the "Corporate Respondents"), and their representatives, agents and employees,

be permanently prohibited and enjoined from engaging in the practice of law as defined in section 1 of the *Legal Profession Act*, S.B.C. 1998, c. 9, including:

- (a) appearing as counsel or advocate;
- (b) drawing, revising or settling
 - (i) a document for use in a proceeding, judicial or extrajudicial,
 - (ii) a document relating in any way to a proceeding under a statute of Canada or British Columbia,
- (c) giving legal advice,
- (d) making an offer to do anything referred to in paragraphs (a) to (c), and
- (e) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a) to (c)

for or in the expectation of a fee, gain or reward, direct or indirect, from the person for whom the acts are performed.

2. Until such time as Mr. Trehan becomes a member in good standing of the Law Society of British Columbia, Mr. Trehan, the Corporate Respondents, and their representatives, agents and employees, be permanently prohibited and enjoined from representing themselves to be any of the following: a lawyer, barrister, solicitor, attorney, counsel, law firm, law corporation, or any other title that connotes that entitlement or qualification to engage in the practice of law.
3. Mr. Trehan take immediate steps to remove any and all links related to the website <http://canada-usa-immigration-ltd.host-glf.com> (the "Website") and remove and delete any links related to the Website including the links at:


