ON THE APPLICATION of the petitioner, the Law Society of British Columbia (the "Law Society"), dated 14 February 2017, coming on for hearing at Vancouver, British Columbia, on July 5 and 6, 2017, and on hearing Michael J. Kleisinger, lawyer for the Law Society and Gerhard Pyper also known as Gerhardus Albertus Pyper ("Mr. Pyper"), appearing on his own behalf, and with reasons being reserved to this date;

THIS COURT ORDERS THAT:

1. Until such time as he becomes a member in good standing of the Law Society or is otherwise permitted by section 15 of the *Legal Profession Act*, S.B.C. 1998, c. 9 (the "Act"), Mr. Pyper is permanently prohibited and enjoined, in the Province of British Columbia, from engaging in the practice of law as defined in section 1 of the *Act*, including:

- (a) appearing as counsel or advocate;

- (b) drawing, revising or settling
 - (i) a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body,
 - (ii) a document for use in a proceeding, judicial or extrajudicial,
 - (iii) a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or a grant of administration or the estate of a deceased person,
 - (iv) a document relating in any way to a proceeding under a statute of Canada or British Columbia, and
 - (v) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (c) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (d) agreeing to place at the disposal of another person the services of a lawyer;
- (e) giving legal advice;
- (f) making an offer to do anything referred to in paragraphs (a) to (e); and
- (g) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a) to (e)


for or in the expectation of a fee, gain or reward, direct or indirect, from the corporation or person for whom the acts are performed.

2. Until such time as he becomes a member in good standing of the Law Society or is otherwise permitted by section 15 of the *Act*, Mr. Pyper is permanently prohibited and enjoined, in the Province of British Columbia, from:
 - a. representing himself as a lawyer or any other title that connotes that he is entitled or qualified to engage in the practice of law; and
 - b. commencing, prosecuting or defending a proceeding in any court, except if representing himself as an individual party to a proceeding, acting without counsel, solely on his own behalf.
3. Mr. Pyper's application for a finding that the Court does not have jurisdiction over him because of institutional bias is dismissed.
4. The Law Society is awarded its costs at Scale B.
5. BY CONSENT, this Order does not prohibit Mr. Pyper from engaging in the acts permitted by section 94.1 of the *Workers Compensation Act*, R.S.B.C 1996, c. 492.
