ON THE APPLICATION of the petitioner, the Law Society of British Columbia (the "Law Society"), without a hearing and by consent:

THIS COURT ORDERS THAT:

1. Until such time as Mumtaz Ali Khan ("Mr. Khan") becomes a member in good standing of the Law Society, Mr. Khan, personally or through any other entity, and M. Khan & Company Immigration Counsellors Ltd. (the "Company"), its representatives, agents and employees, are permanently prohibited and enjoined from engaging in the practice of law as defined in section 1 of the *Legal Profession Act*, S.B.C. 1998, c. 9, including:

- (a) appearing as counsel or advocate;


- (b) drawing, revising or settling
  - (i) a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body,
  - (ii) a document for use in a proceeding, judicial or extrajudicial,
  - (iii) a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or a grant of administration or the estate of a deceased person,
  - (iv) a document relating in any way to a proceeding under a statute of Canada or British Columbia, and
  - (v) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (c) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (d) agreeing to place at the disposal of another person the services of a lawyer;
- (e) giving legal advice;
- (f) making an offer to do anything referred to in paragraphs (a) to (e);
- (g) making a representation that they are qualified or entitled to do anything referred to in paragraphs (a) to (e)

for or in the expectation of a fee, gain or reward, direct or indirect, from the person for whom the acts are performed.

2. Until such time as Mr. Khan becomes a member in good standing of the Law Society, Mr. Khan, the Company and its representatives, agents and employees, are permanently prohibited and enjoined from:
  - a. commencing, prosecuting or defending a proceeding in any court, except if representing themselves as individual parties to a proceeding, acting without counsel, solely on their own behalf; and
  - b. representing themselves as being lawyers, a law firm or any other title that connotes that they are entitled or qualified to engage in the practice of law.
3. Notwithstanding this order, Mr. Khan and the Company may perform such acts as permitted by the federal immigration statutes provided they perform those acts while members in good standing of the Immigration Consultants of Canada Regulatory Council.
4. On or before January 26, 2018, by certified cheque or bank draft, the respondents will pay \$2,500 to the Law Society to be held in trust for Panha Chhorn (\$1,500) and Thearath Thera (\$1,000).

5. Costs are neither sought nor awarded.
