ON THE APPLICATION of the petitioner, the Law Society of British Columbia (the "Law Society"), without a hearing and by consent:

THIS COURT ORDERS THAT:

 Until such time as they become members in good standing of the Law Society, Wesley Robert Stevenson a.k.a. Wes Stevenson, Kristine Loretta Stevenson a.k.a. Kirsty Stevenson a.k.a. Kristy Bieker, and Okanagan Divorce Solutions Inc., all doing business as 'www.kelownadivorce.ca', Kelowna Divorce Mediation Services and Kelowna Divorce Mediation are permanently prohibited and enjoined from engaging in the practice of law as defined in section 1 of the *Legal Profession Act*, S.B.C. 1998, c. 9, including:

- (a) appearing as counsel or advocate;
- (b) drawing, revising or settling
 - (i) a petition, memorandum, notice of articles or articles under the Business Corporations Act, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body;
 - (ii) a document for use in a proceeding, judicial or extrajudicial,
 - (iii) a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or a grant of administration or the estate of a deceased person,
 - (iv) a document relating in any way to a proceeding under a statute of Canada or British Columbia;
 - (v) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (d) agreeing to place at the disposal of another person the services of a lawyer;
- (e) giving legal advice;
- (f) making an offer to do anything referred to in paragraphs (a) to (e); and
- (g) making a representation that they are qualified or entitled to do anything referred to in paragraphs (a) to (e)

for or in the expectation of a fee, gain or reward, direct or indirect from the person for whom the acts are performed.

- 2. Until such time as they become members in good standing of the Law Society, Mr. Stevenson are Ms. Bieker are permanently prohibited and enjoined from:
 - a. commencing, prosecuting or defending a proceeding in any court, except if representing themselves as individual parties to a proceeding, acting without counsel, solely on their own behalf; and
 - b. representing themselves as lawyers or any other titles that connote that they are qualified or entitled to practise law.
- 3. The parties will bear their own costs.
