- B. The Law Society received a complaint or complaints relating to the undersigned's performance of such acts.
- C. The undersigned has been advised to seek legal advice about this matter and has had the opportunity to seek legal advice prior to entering into this written commitment.
- D. The undersigned makes this written commitment to assist the Law Society determine what further action the Law Society may take regarding the complaint or complaints and understands that the Law Society may initiate proceedings pursuant to section 85 of the *Legal Profession Act* if it receives evidence that the undersigned has acted contrary to the *Act*.

I, **SANAZ ROSTAM SADEGHI**, agree not to perform any of the acts defined in the *Legal Profession Act* or any successor legislation as the practice of law. I specifically agree that I will not, either personally or through any other entity, perform the following acts for or in the expectation of a fee, gain or reward, direct or indirect, from the person for whom the acts are performed, including:

- (a) appearing as counsel or advocate;
- (b) drawing, revising or settling a petition, memorandum, notice of articles or articles under the *Business Corporations Act*, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body;
- (c) drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
- (d) drawing, revising or settling a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or a grant of administration or the estate of a deceased person;
- (e) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia;

- (f) drawing, revising or settling an instrument relating to real or personal estate which is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (g) doing any act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
- (h) agreeing to place at the disposal of another person the services of a lawyer;
- (i) giving legal advice;
- (j) making an offer to do anything referred to in paragraphs (a) to (i); and
- (k) making a representation that I am qualified or entitled to do anything referred to in paragraphs (a) to (i).

- (a) a lawyer;
- (b) an articulated student, a student-at-law or a law clerk;

- (d) a practitioner of foreign law holding a permit under section 17(1)(a) of the *Legal Profession Act* or any successor legislation, to the extent permitted under that section.
