We provided surety bond services for freight shipping from pick up through safe delivery between M.T.TORIMATSU CO LTD 2-18, Butsuryu-Center, Tsubame-shi, Niigata, Japan Zip: 9591277 herein referred to as "Principal" and Peerless, E B Ltd 6651 Elmbridge Way Suite 130 Richmond, BC V7C 5C2, Canada shipper herein referred to as "Obligee".

According to the terms of the contract agreement, obligee is fully responsible for replacement cost of damaged cargo during shipping. obligee is at default as some items were broken and damaged with cost amounting to \$480,560. Upon investigation, we discovered that obligee was responsible. We informed obligee of this and they agreed to pay for damages. Since then we have made several contacts on behalf of principal, to obligee demanding for payments.
