#### **BIOGRAPHICAL INFORMATION**

Roland is 54 years of age and a lifelong resident of British Columbia. He has lived in the Kootenay since 1998.

He has a black belt in karate and kobudo, and was a karate instructor prior to law school. He is a Rescue Diver and Master Scuba Diver, as well as a former ocean lifeguard, Ironman triathlete, and varsity swimmer. Roland has an undergraduate degree in criminology and graduated from law school in 1997. He resides with his lovely wife in Trail, B.C., where they raised two children who are now attending university.

Roland has a history of community involvement and is a current member of the Trail Community Safety Task Force where board members look at strategies to reduce crime and increase public safety. Roland previously sat on the executive of the Kootenay Bar Association for several years and is a prior President of the KBA.

Roland previously worked as federal crown for ten years, but his current and long term primary area of practice has been family law. He is a family law lawyer, mediator, arbitrator, and parenting coordinator. He was member of the CBABC Practice Advisory Panel for family law for close to a decade.

#### **ELECTION STATEMENT**

I have had the privilege of practising law in the Kootenay for over 25 years, appearing in virtually every registry in the region, initially as federal crown counsel and later in the primary field of family law.

Those who know me are aware of my efforts during and since my time as KBA President to push back against efforts to undermine the independence of the bar and the ability of the legal profession to self-regulate. Both professional and regulatory independence are critical so that lawyers can act in the best interests of clients, even when those interests conflict with government or other powerful actors. Our standards of admission, conduct, and discipline, must be overseen by the legal profession itself and not the executive branch of

whatever government is in power at the time. We have seen in other jurisdictions, the threats to the rule of law, to institutional checks and balances, to the protection of minority rights, and an overall weakening of public confidence in the justice system, when government oversteps.

I am fully aware that depending on the outcome of upcoming litigation between the LSBC and BC Government, this may be the last elected Bencher position for Kootenay. There are no guarantees that the upcoming Bencher would be able to complete their full term. If we effectively end up with a state-controlled law society, the Kootenay may or may not end up with a long term elected Bencher or representative at all. All I can promise is that as a Bencher for the Kootenay I would continue to advocate for professional and regulatory independence for the Bar in every way possible and for as long as possible, as this is essential for the protection of the public and the clients who we serve in the Kootenay.

I also intend to continue to argue that access to justice needs to involve access to properly trained lawyers and properly funded court services, not the replacement of lawyers or further cuts to those services.

#### **BIOGRAPHICAL INFORMATION**

Karen Tse, K.C. is a rural family lawyer, family law mediator, Legal Aid BC duty counsel and civil litigator. Karen is a partner at Rockies Law LLP and practices from Fernie. Karen represents the Kootenay region as the president of the Kootenay Bar Association (KBA) and she serves as the Kootenay representative on the Continuing Legal Education Society of British Columbia Board. She is dedicated to promoting access to justice in rural communities and providing mentorship to the Kootenay bar. For many years, she served on the board of the CBABC Rural Education and Access to Lawyer Initiative. Karen became one of the youngest lawyers to be appointed Kings Counsel in British Columbia this past year. She was also named volunteer of the year by the Fernie Chamber of Commerce. As president of the KBA, she has launched a peer-mentorship network and liaised with the Penticton Bar to bring regional workshops to the Kootenays. Outside of the office, her work with the Fernie Women's Resource Centre continues to support rural families accessing child care and women and children in crisis.

Karen hopes to bring her energy and passion to the role of Bencher. As president of the Kootenay Bar Association, Karen has been a strong advocate for the lawyers of the Kootenays. She has worked diligently to liaise with the Law Society of British Columbia and the Canadian Bar Association of British Columbia to build strong relationships with Kootenay lawyers. She also works to foster a welcoming and collegial bar that one would be proud to be a part of.

For many years, Karen served on the CBABC Rural Education and Access to Lawyer Initiative advocating for access to justice in rural high needs communities. Through that program and during Karen's tenure, many students have been placed throughout the Kootenays.

Karen is passionate about supporting articling students and new lawyers, having served as a mentor to many lawyers entering the legal profession in the Kootenays. She also began a mentorship network initiative in the Kootenays and has served as a liaison to bring regional workshops hosted by the Judiciary to the Kootenay bar. Karen is passionate about access to legal education and currently serves as the representative of the Kootenays on the board of the Continuing Legal Education Society of British Columbia.
