#### **ELECTION STATEMENT**

For the past two years, it has been my privilege to serve as a Bencher for Victoria. I am seeking re-election because there is more to do, and because I believe that the independence of the legal profession and the rule of law are under serious and growing pressure — both abroad and here at home.

The rule of law is under attack, and we must all take steps to educate the public about its value in a democratic society. The Law Society must be at the vanguard of this effort.

Recent events around the world remind us how fragile this foundation can be. In the United States, judges have been sanctioned for fulfilling their duties, vessels and lives have been destroyed without legal process, and journalists and critics have faced open threats. These are not distant or abstract concerns; they show how quickly societies can slide from lawful governance into authoritarian rule.

Here in British Columbia, Bill 21 — which would create a single legal regulator — threatens the independence of lawyers and, with it, the protection of every citizen's rights. This fundamental issue is now before the courts, with the Law Society leading a constitutional challenge in October 2025 to defend our independence and, indirectly, that of the judiciary.

The independence of the bar and the judiciary is not a privilege of lawyers; it is the public's safeguard against the abuse of power. As Benchers, our duty is to defend that independence, to ensure that the profession remains self-governing, and to uphold the rule of law that sustains our democracy.

If re-elected, I will continue to speak and act work hard to protect these principles. The rule of law will not defend itself — it requires all of us, especially lawyers, to stand up, speak out, and protect the hard-won rights of our democracy.

#### **BIOGRAPHICAL INFORMATION**

For the last 36 years, I have practiced exclusively in management side employment, labour, administrative and human rights law. Following a clerkship with the BC Court of Appeal, my practice has included two years as a staff lawyer at the BC Labour Relations Board and 3 years with the then Public Service Employee Relations Commission (now the Public Service Agency). I was the inaugural Chair of the Industry Training Appeal Board and a Vice Chair of the Community Care and Assisted Living Appeal Board.

In 2013, I was retained by the Province to conduct an independent review of the process followed by the public service in dismissing a number of unionized and management employees in the Ministry of Health. The government accepted my findings, which led to significant changes in the Province's practices in relation to employee discipline and discharge.

In 2013 and 2023, I was a sessional lecturer in Employment Law at the University of Victoria. I am currently on the Board of the Belfry Theatre and have previously been a Director of the Victoria Hospitals Foundation Board and the Canadian Heritage Arts Society. I was elected as a bencher in January 2025.

#### **ELECTION STATEMENT**

I was deeply honoured to be elected as a bencher in the January 2025 by-election. Since my appointment, I have served on the Practice Standards Committee and on the Bullying, Harassment and Discrimination Task Force. In each of these roles as well as at the bencher table I have drawn on my extensive practice experience to advocate for the protection of due process and fair hearing rights. This work has reinforced my dedication to support the integrity of our justice system.

As current world politics shows us, we cannot take these foundational principles of our justice system for granted as they are quickly eroded when the independence of lawyers and

judges is undermined. I strongly support the Law Society's efforts to oppose the amendments introduced in the *Legal Professions Act* that would challenge our independence and pose a threat to our profession's impartiality and fairness.

Since attending my first bencher meeting this year, I have been impressed with the diversity of perspectives that is represented at the table. In addition to racial and gender diversity, the current group of benchers also come from different practice areas; and represent a wide range of years of call as well as practice formats. Regional diversity is also enshrined in our current legislation but would be undermined if the Law Society's challenge to the *Legal Professions Act* is unsuccessful. Diversity fosters broader understanding, supports healthy and nuanced debate at the bencher table and ensures that our decisions reflect the realities of the communities we serve. These values support the public's trust in our profession and in our legal institutions.

This work is central to my commitment to ensure that the highest standards of ethics and integrity are reflected in our profession. I hope to be able to continue this critical work for the next two years and to continue to deepen my understanding of the issues and challenges we face as a profession. I hope that you will give me that opportunity and that you will vote for me to rejoin the benchers for another term.
