CONSENT ORDER

ON THE APPLICATION of the petitioner, the Law Society of British Columbia (the “Law Society”), without a hearing and by consent;

THIS COURT ORDERS that:

1. Until Esther Anita Sharaf becomes a member in good standing of the Law Society, Esther Anita Sharaf and All Nations Business Association Ltd. aka ANBA Ltd. are permanently prohibited and enjoined from engaging in the practice of law as defined in section 1 of the *Legal Profession Act*, S.B.C. 1998, c. 9, including:
 - (a) appearing as counsel or advocate;
 - (b) drawing, revising or settling
 - (i) a petition, memorandum, notice of articles or articles under the Business Corporations Act, or an application, statement, affidavit, minute, resolution, bylaw or other document relating to the incorporation, registration, organization, reorganization, dissolution or winding up of a corporate body;

- (ii) a document for use in a proceeding, judicial or extrajudicial;
 - (iii) a will, deed of settlement, trust deed, power of attorney or a document relating to a probate or a grant of administration or the estate of a deceased person;
 - (iv) a document relating in any way to a proceeding under a statute of Canada or British Columbia;
 - (v) an instrument relating to real or personal estate that is intended, permitted or required to be registered, recorded or filed in a registry or other public office;
- (c) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
 - (d) agreeing to place at the disposal of another person the services of a lawyer;
 - (e) giving legal advice;
 - (f) making an offer to do anything referred to in paragraphs (a) to (e); and
 - (g) making a representation that he is qualified or entitled to do anything referred to in paragraphs (a) to (e)

for or in the expectation of a fee, gain or reward, direct or indirect from the person for whom the acts are performed.


2. Until Esther Anita Sharaf becomes a member in good standing of the Law Society, Esther Anita Sharaf and All Nations Business Association Ltd. aka ANBA Ltd. are permanently prohibited and enjoined from representing themselves as being a lawyer, counsel, solicitor, law firm, immigration practice, or any other title that connotes they are qualified or entitled to engage in the practice of law;
3. Esther Anita Sharaf and All Nations Business Association Ltd. must jointly and severally pay restitution in the amount of \$25,000 to the Law Society of British Columbia to be held in trust for Sharoon Rimzeun Haroon.

4. Esther Anita Sharaf and All Nations Business Association Ltd. must pay one set of costs to the Law Society fixed in the amount of \$500.


